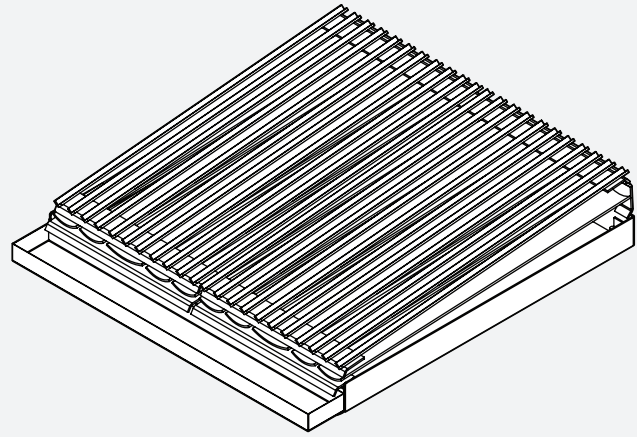
Front View
